MEMBERSHIP AGREEMENT

The following conditions are to be read fully and signed prior to completing an acceptance form for membership. Anyone who subscribes for membership or who is issued membership shall not be entitled use of the facilities until a copy of this form has been signed, indicating their acceptance of the terms and conditions and a copy thereof has been accepted by the Club and furnished to the applicant.

1. Upon payment and completion of application form, membership to the Azure Leisure Club & Spa will entitle the Member to full use of its facilities.
2. In the interests of safety use of the facilities of the Leisure Club is strictly subject to the rules and regulations within the Leisure Club.
3. Payment of membership fees will entitle the Member to a membership to the Leisure Club for a twelve month period.
4. In the event of membership not renewed within 14 days of its expiry, it is deemed to have expired and will be necessary for the Member to re-apply.
5. Members paying by Direct Debit method must sign and read carefully conditions outlined on the Direct Debit mandate form.
6. Cancellation of membership must be done in writing to the Leisure Club and bank informing of your decision.
7. Direct Debit membership is will be automatically renewed unless otherwise instructed by member in writing.
8. Joining fees are only refundable upon completion of a full years Direct Debit to the Leisure Club.
9. On becoming a Member of Azure Leisure Club, keyrings will be issued and must be presented and swiped on each visit.
10. Student rates only apply to those in full time education. Proof of education is required upon joining the Leisure Club.
11. Children aged 3 or under at the date of joining are free of charge.
12. Children 15 and under must leave the pool by 7pm. Any children under the age of 10 must be accompanied by an adult at all times.
13. Smoking or possession or consumption of alcoholic beverages within the Leisure Club is not permitted.
14. The Management reserves the right to utilise the Leisure Club facilities for other events as determined by Management.
15. Membership fees are not refundable, even in the case of injury, illness, change of residence or employment.
16. The Member acknowledges that the Leisure Club will not be responsible for the loss of any personal items or damage to personal property within the Leisure Club premises.
17. The Member acknowledges that the Leisure Club accepts no liability for any personal injury sustained and acknowledges that he/she uses the facilities, apparatus and equipment entirely at his/her own risk.
18. The Member warrants that he/she is in good health and not suffering from any illness or injury.
19. Management reserves the right to terminate membership without notice. It is the sole discretion of Management whether or not membership fees are refundable and to give no reasons for non acceptance.
20. Membership may be terminated by the Management for violation of any of the Rules & Regulations of the Leisure Club or for conduct deemed by Management detrimental to the welfare, good order or character of the Leisure Club and its Members.
21. The Use of Mobile Phones, Cameras and camcorders is not permitted in the changing rooms or Swimming area. Membership may be terminated immediately should this rule be broken
