MEMBERSHIP AGREEMENT

This agreement must be read carefully and signed prior to completing a membership application. Membership and access to the facilities are only granted upon submission of a signed copy of this form and its acceptance by Azure Leisure Club.

Terms & Conditions

1. Membership grants access to all Azure Leisure Club & Spa facilities upon payment and completion of the application form.
2. For safety reasons, use of the facilities is subject to the Club's rules and regulations at all times.
3. If membership is not renewed within 14 days of its expiry, it will be considered lapsed and a new application must be submitted.
4. Members paying by Direct Debit method must sign and read carefully conditions outlined on the Direct Debit form.
5. For Direct Debit members, the first and last month's fees are payable upfront. If the member cancels before the end of the 12-month period, the final month's payment is non-refundable. No membership suspensions or refunds are available, including for medical reasons, injuries, or holidays.
6. Direct Debit memberships automatically renew unless cancellation is received in writing.
7. Members will receive a keyring, which must be scanned upon each visit.
8. Student rates are available only to those in full-time education. Valid Student ID is required at the time of joining.
9. Children aged 3 and under may join free of charge.
10. Children turning 4 during the membership year will be upgraded to a child membership and charged the applicable fee for the remaining term.
11. Children aged 15 and under must vacate the pool by 7:00 PM daily. Children under 15 must be accompanied by an adult at all times.
12. Smoking or possession or consumption of alcoholic beverages within the Leisure Club is not permitted.
13. The Management reserves the right to utilise the Leisure Club facilities for other events as determined by the Management.
14. Membership fees are not refundable, even in the case of injury, illness, change of residence or employment.
15. The Club is not responsible for lost or damaged personal belongings.
16. Members acknowledge that use of facilities and equipment is at their own risk. The Club is not liable for any personal injuries sustained.
17. Members confirm they are in good health and not suffering from any illness or injury.
18. Management reserves the right to terminate membership without notice. It is the sole discretion of Management whether or not membership fees are refundable and to give no reasons for non-acceptance.
19. Membership may be terminated by the Management for violation of any of the Rules & Regulations of the Leisure Club or for conduct deemed by Management detrimental of the welfare, good order or character of the Leisure Club and its Members.
20. The use of mobile phones, cameras, or recording devices is strictly prohibited in changing areas and the pool. Breach of this rule may result in immediate termination of membership.
